

## **SUMMARY ANNUAL REPORT**

This is a summary of the annual report of the Genesys Telecommunications Laboratories, Inc Health & Welfare Plan, EIN 94-3120525, Plan No. 502, for period January 01, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Life Insurance Company of North America, Anthem Blue Cross Life and Health Insurance Company, Kaiser Foundation Health Plan Inc, Unitedhealthcare Insurance Company, Connecticut General Life Insurance Company, and Vision Service Plan to pay health, dental, vision, life insurance, temporary disability, long-term disability, and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2019 were \$39,600,041.
